NY Project Hope also has digital educational materials, a supportive social media presence, a website filled with resources along with a helpline that the community can access. Crisis counselors can also present at virtual events and can also hold “conversation cafe’s,” support groups, create virtual presentations, hold drop-in educational sessions at a set time each week or month, etc. A crisis counselor can link an individual to needed community-based resources such as food banks, unemployment benefits, social services, healthcare, and behavioral healthcare, emergency management, COVID testing, vaccine testing resources to name only a few.

Housing Stability Program is designed to assist low- to moderate- income New Yorkers who are at risk of losing their homes due to financial distress caused by the COVID-19 pandemic. Eligible participants may receive a consumer up to \$10,000. Established with funds from Citi Community Investing and Development, the program is open to homeowners and renters in New York City, Long Island, and Westchester County. Please call us to schedule an appointment to speak with a lending specialist about the program.

Sustainable Neighborhoods, in partnership with New York State Homes and Community Renewal (HCR), is establishing an affordable refinance pilot program aimed at settling outstanding mortgage debt for homeowners at risk of foreclosure. The pilot will help a small number of homeowners in foreclosure by paying off the entirety of their existing mortgage debt and refinancing these homeowners into a new mortgage or mortgages. This program is designed to assist homeowners who have fallen behind on their mortgage due to hardship but have since stabilized their finances and can afford to repay a refinanced loan. Homeowners must apply through a housing counselor.
